

**PUBLIC NOTICE**  
**LOUISIANA DEPARTMENT OF ENVIRONMENTAL QUALITY (LDEQ)**  
**DTM LOUISIANA GATHERING, LLC - PELICAN FACILITY**  
**DRAFT WATER DISCHARGE PERMIT**

The LDEQ, Office of Environmental Services, is accepting written comments on a draft Louisiana Pollutant Discharge Elimination System (LPDES) permit prepared for DTM Louisiana Gathering, LLC, Pelican Facility, 9803 Highway 171, Grand Cane, Louisiana 71032. The facility is located at **2943 Cross Road in Pelican, DeSoto Parish.**

The principal discharge from this existing source is made into local drainage via an effluent pipe, thence into Belle Bayou, waters of the state classified for primary contact recreation, secondary contact recreation, propagation of fish and wildlife, and agriculture. Under the SIC Code 1311, the applicant proposes to discharge reject water from the reverse osmosis system from an existing natural gas production facility.

During the preparation of this permit, it has been determined that the discharge will have no adverse impact on the existing uses of the receiving waterbody. As with any discharge, however, some change in existing water quality may occur.

If LDEQ finds a significant degree of public interest, a public hearing will be held. LDEQ will send notification of the final permit decision to the applicant and to each person who has submitted written comments or a written request for notification of the final decision.
